Name of problem PSN005966u – SAL Policy Manager Log4j vulnerabilities.

Products affected

SAL Policy Manager 3.0, 3.1 and 3.2.

Problem description

Avaya is aware of the recently identified Apache Log4j vulnerabilities ([CVE-2021-44228](#), [CVE-2021-45046](#), [CVE-2021-45105](#), [CVE-2021-44832](#), [CVE-2021-4104](#)) and is conducting impact assessments across its portfolio, identifying opportunities for temporary mitigations, if possible, and developing plans for remediation. Reference the *Avaya Product Security - Apache Log4j Vulnerability - Impact for Avaya products* on support.avaya.com for updates

SAL Policy Manager 3.0, 3.1, and 3.2 is running Log4jv1 that is not susceptible to CVE-2021-44228, CVE-2021-45046, CVE-2021-45105, CVE-2021-44832 and CVE-2021-4104.

The internal analysis has determined that these releases are not vulnerable to the related Log4j1x plus JMSAppender vulnerability as the log4j configuration doesn't use JMSAppender.

Even though earlier versions are not vulnerable, Avaya recommends upgrading to the latest update on Java 8 and SAL Policy Manager 3.2 for quicker access to future resolutions.

Please only follow documented procedures described in this PSN to resolve this issue.
